### 1. Controller

### 2. Applicable law

We process personal data in accordance with the **EU General Data Protection Regulation (Regulation (EU) 2016/679)** and the **Maltese Data Protection Act (Chapter 586)**, as applicable.

### 3. What data we process and why

#### a) Website access (server logs)

When you visit this website, technical data may be processed, such as:

- IP address (or parts thereof, depending on configuration)
- date and time of access
- pages accessed / requested files
- referrer URL
- browser type/version, operating system
- device and technical information required to deliver the website

**Purpose:** delivering the website, ensuring stability and security, troubleshooting

**Legal basis:** our legitimate interests in operating a secure and reliable website (Art. 6(1)(f) GDPR)

#### b) Contact form

If you submit the contact form, we process the data you provide (e.g., name, email address, message and any additional details you choose to include).

**Purpose:** responding to your enquiry, initiating and managing a potential contractual relationship

**Legal basis:** processing necessary for pre-contractual measures / contract (Art. 6(1)(b) GDPR), and where applicable legitimate interests in efficient communication (Art. 6(1)(f) GDPR)

### 4. Hosting and website platform (Onepage.io)

This landing page is created and hosted using **Onepage** (Onepage GmbH, Hanauer Landstraße 172, 60314 Frankfurt am Main, Germany). Onepage may process personal data on our behalf as a **data processor** for hosting and technical operation purposes.

We use Onepage to provide the website and the contact form functionality. Data may be processed within the EU/EEA and subject to appropriate contractual safeguards where required.

## 5. Cookies

We may use **strictly necessary cookies** or similar technologies to operate and secure this website and to provide essential functions. Where additional cookies/technologies require consent, we will request it before such processing takes place.

## 6. Data sharing and recipients

We do not sell personal data. We share personal data only:

- with service providers acting on our instructions (e.g., hosting/website platform) where necessary to operate the website and handle enquiries, and/or
- where legally required, and/or
- where necessary to establish, exercise, or defend legal claims.

## 7. International transfers

If personal data is transferred outside the EU/EEA in specific cases, we will ensure that such transfers comply with applicable law (e.g., adequacy decision or appropriate safeguards such as Standard Contractual Clauses).

## 8. Data retention

We retain personal data only as long as necessary for the purposes described:

- **Server logs:** retained for a limited period as required for security and troubleshooting
- **Contact enquiries:** retained for as long as needed to handle the enquiry and any resulting relationship, and longer only if required by law or necessary for legal claims.

## 9. Security

We implement appropriate technical and organisational measures to protect personal data against accidental or unlawful destruction, loss, alteration, unauthorised disclosure, or access. Data transmissions are typically encrypted (HTTPS), where supported.

## 10. Your rights

Subject to applicable law, you have the right to:

- access your personal data
- request rectification
- request erasure
- request restriction of processing
- request data portability
- object to processing based on legitimate interests
- withdraw consent at any time where processing is based on consent
