Our Commitment

Strategikon Pharma's Privacy Policy (henceforth referred to as Policy) has been established to demonstrate our commitment to protecting the privacy of your information regardless of whether you are our customer or a visitor.

In this Policy, we describe how we collect, use, and disclose information that we obtain and what your rights are in this regard. This Policy applies to Strategikon Pharma and its subsidiaries.

Our Commitment to GDPR

Strategikon Pharma is committed to ensuring the security and protection of the personal information that we process, and to provide a compliant and consistent approach to data protection. We have always had a robust and effective data protection program in place which complies with existing law and abides by the data protection principles. However, we recognize our obligations in updating and expanding this program to meet the demands of the GDPR.

Strategikon Pharma is dedicated to safeguarding the personal information under our remit and has developed a data protection regime that is effective, fit for purpose and demonstrates an understanding of, and appreciation for the new Regulation. Our preparation and objectives for GDPR compliance include the development and implementation of new data protection roles, policies, procedures, controls, and measures to ensure maximum and ongoing compliance.

Information Collection & Use

While using our Site or services, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you; the type of information collected shall be based on your interaction with us but may include your name, company name and address, contact information (phone and email), billing information, credit card details and any other information you choose to provide.

In addition to the above we may also collect information automatically which may include information about your use of our Sites or online Services through cookies (refer section 4), log files and other technologies. The information collected may include your domain name, your browser type and operating system, web pages you view, links you click, your IP address, the length of time you visit our

Sites or use our Services, your activities on our Sites or Services (including your movement through our Sites), and the referring URL or the webpage that led you to our Sites.

How we use the information

The information collected by us may be used for the following purpose

- For the purpose for which you specifically provided the information to us, including, to respond to your inquiries, to provide any information that you request, to address trouble tickets, and for providing customer service.
- To deliver customized content to you, to offer location customization, personalized help, and instructions, and to otherwise personalize your experiences while using our Sites or our Services.
- The information may also be shared with marketing and sales partner to contact you with newsletters, special offers and promotions, or to otherwise contact you about products or information we think may interest you as well as to track the success of our marketing and advertising campaigns.

All financial and billing information that we collect is used solely to check the qualifications of prospective customers and to bill for services. This billing information is not used by us for marketing or promotional purposes.

Cookie Policy

A cookie is a small file of letters and numbers that is placed on your web browser, or on the hard drive of your computer or mobile device that will enable us to distinguish you from other users and provide you with a meaningful experience when you browse the website. Tracking cookies also allows us to improve the site for all our users. Cookies cannot be used to run programs or deliver viruses to your computer.

Cookies merely recognize your browser. Unless you choose to identify yourself, you remain anonymous to us.

We at Strategikon Pharma collect two types of cookies

- Session cookies: these cookies are temporary and only last as long a user's 'browser session'. A browser session starts when a user opens the browser window and finishes when they close the browser window. Once the browser is closed, all session cookies will be deleted.
- Persistent cookies: these cookies remain on a user's device after a browser session has finished. How long each cookie lasts will be specified by each cookie. Persistent cookies will be activated each time that a user revisits the website that placed the cookie.

Google Analytics

Strategikon Pharma uses Google Analytics, a web analytics service provided by Google, Inc. ("Google"). Google Analytics uses "cookies", which are text files placed on your computer, to help a website analyze how users use the site. On behalf of the website provider, Google will use this information for the purpose of evaluating your use of the website, compiling reports on website activity for website operators and providing other services relating to website activity and internet usage to the website provider. You may refuse the use of cookies by selecting the appropriate settings on your browser. However, please note that if you do this, you may not be able to use the full functionality of this website. - We may share information with our marketing and sales partners as part of marketing/advertising campaign.

• We may also share information with third parties that are involved in study management (commonly practiced in our industry).

Strategikon Pharma reserves the right to share aggregate or de-identified information about users with third parties for marketing, advertising, research, or similar purposes.

Job Applicants

If you submit your resume or otherwise apply for a job with Strategikon Pharma or its subsidiaries, the information submitted by you shall be used and disclosed only for employment consideration, unless additional consent is obtained from you.

Security

The security of your Personal Information is important to us but remember that no method of transmission over the Internet, or method of electronic storage, is 100% secure. Processing fee may be applicable if the request is found to be manifestly unfounded or excessive. If we charge a fee, we will inform you of this and explain the reasons for doing so.

Steps will also be taken to verify the requestor's identity prior to initiation of action.

For Data Portability requests the data shall be transferred only if found to be technically feasible. If the request is complex and cannot be completed within the 30-day time frame we may extend the timeline; however, we will keep you informed of such extension with the reason for the same.
