

# Terms of Service

Welcome to **Untapped Society** ("Untapped", "we", "us", or "our"). By registering as a member, accessing our services, attending our events, or engaging in our platform in any capacity, **you agree to be bound by these Terms of Service**, our [Privacy Policy](#), and our **Untapped Rules** (collectively, the "Agreement").

Please read these Terms carefully. Violation of any clause may result in suspension or termination of membership, legal action, or permanent exclusion from the community.

## 1. Membership Eligibility and Conduct

Untapped Society is an exclusive private club and community for gay entrepreneurs, professionals, and like-minded individuals. By joining, you affirm that:

- You are 18 years or older
- You meet the membership criteria set by Untapped
- You will participate respectfully and align with the values of the community
- You will not impersonate another person or misrepresent your identity

## 2. Respect, Behaviour & Anti-Harassment

All members agree to uphold a respectful environment. Any form of **disturbing, unwanted, or disrespectful behaviour toward** Joey (the founder), the Untapped team, or other members will not be tolerated. This includes, but is not limited to:

- Harassment or bullying (online or in person)
- Public disruption or scenes at events
- Ignoring or violating personal boundaries
- Slander, libel, or defamation
- Threats, intimidation, or inappropriate conduct

Violations will be dealt with proportionately — up to and including **immediate membership revocation, lifetime bans**, and legal reporting where applicable.

### 3. Use of Member Data & Confidentiality

As a member, you acknowledge and agree that:

- You may view **other members' personal information** (e.g. names, locations, occupations, industries, social media links) strictly **within the context of Untapped**.
- You are **prohibited** from using, saving, copying, reproducing, or sharing any data, contacts, content, or information gained through your membership **outside the platform**, unless you have **explicit written permission** from the individual concerned.
- You are **not permitted to use member data** for your own business, marketing purposes, or personal advantage without authorisation.

### 4. Non-Compete Clause

By joining Untapped Society, you agree that:

- You will **not directly or indirectly** create, assist, or support any competing business, community, club, or platform that is **substantially similar** in concept, offering, audience, or structure using knowledge, contacts, or insights gained through Untapped.
- This includes but is not limited to: copying community structure, curating similar events for a similar audience, or contacting members gained through Untapped for your own commercial or community benefit.

Violation of this clause may lead to **immediate termination**, legal proceedings, and claims for damages.

### 5. Payments, Cancellations & Refunds

- Members can **cancel their membership at any time** via their account or by contacting support.
- We reserve the right to cancel or reschedule events and will always aim to communicate changes clearly and in good time.

### 6. Community Use & Intellectual Property

- All content provided through Untapped (website content, design, events, communications, branding, platform features, and community content) remains the **intellectual property of Untapped Society**.
- You may not copy, reproduce, distribute, or adapt any such content without express written permission.
- Likewise, you do **not own** the rights to any other member's content, photos, data, or statements. Sharing such content outside of Untapped is strictly prohibited.

## 7. Platform Usage

You agree to:

- Use the platform only for lawful purposes and in line with these Terms
- Not misuse the platform to solicit, spam, or manipulate other users
- Not attempt to reverse-engineer, hack, or interfere with the platform's code or structure
- Not create multiple accounts or impersonate others

## 8. Event Liability Disclaimer

Participation in any physical event, trip, or gathering organised by Untapped Society is at your own risk. Untapped is **not liable** for any injury, illness, loss, damage, or inconvenience sustained during or as a result of attending an event, including but not limited to:

- Accidents or personal injury
- Illness or infection
- Transport disruptions or delays
- Theft or loss of property

We recommend you hold your own travel and personal liability insurance when attending any in-person event or retreat.

## 9. Termination of Membership

We reserve the right to suspend or terminate your membership without refund if:

- You breach any part of this Agreement
- Your behaviour threatens the safety or integrity of the community
- You engage in abusive, harassing, or damaging behaviour toward the team or other members

Termination may be permanent depending on severity.

## 10. Changes to Terms

We may update these Terms from time to time. Significant changes will be communicated via email or within the platform. Continued use of the platform constitutes your acceptance of the updated Terms.

## 11. Governing Law

This Agreement shall be governed and construed in accordance with the laws of the **United Kingdom**. All disputes shall be subject to the **exclusive jurisdiction of the UK courts**.
